The Electoral Commission of Queensland wrote this form. When you see the word 'we', it means the Electoral Commission of Queensland.



We wrote this form in an easy to read way.

We use pictures to explain some ideas.

BoldNot bold

We wrote some important words in **bold**.

This means the letters are thicker and darker.



We explain what these bold words mean.

This is an Easy Read summary of another form.

This means it only includes the most important ideas.

What is an Election summary return?



We have a law in Queensland called the Local Government Electoral Act 2011 (the Act).



The Act explains the rules that everyone must follow in a local government election in Queensland.



The Act says that all **candidates** must fill out an Election summary return.

A candidate is a person that people can vote for in an election.









You need to fill out an Election summary return so we know how much money you:





• received from other people



• borrowed – we use the word loan



spent.



This also includes telling us about any **gifts**.

A gift is when someone gives you something without wanting anything in return.

For example:

- money
- services.









Who needs to fill out an Election summary return?



All candidates need to fill out an Election summary return.

This includes candidates who did not win the election.

You need to fill out the Election summary return even if you did not:



receive any money or loans



• spend any money.









How to fill out the Election summary return



The Election summary return has 5 different parts.



In each part we will ask you some questions.



We might ask you to tick a box that has the best answer for you.



We might ask you to fill out an answer in a box.



You will need to sign the Election summary return after you have answered the questions.











There are different ways you can send your finished Election summary return to us.

When is the Election summary return due?



You need to send us your Election summary return within 15 weeks after the day of the election.











Part A - the name of the election

We need to know which election you took part in.



For example:

- a local council by-election
- an event like the 2024 local government elections.

Part B - your name



We need to know your name.



Your name must be the same as what you wrote on your nomination form.

This is the form you filled out to become a candidate.

Part C – the disclosure period



You need to tell us about any money you spent or received during a certain period of time.

We call this the disclosure period.



A disclosure period has a:

- start date
- end date.

If you were, your start date is 30 days after the date of the last election you took part in.











If you haven't been a candidate in the last 5 years, we have some questions that can help you work out the start date:



When did you start doing activities for this election?
This is called campaigning.



What date did you fill out your nomination form?



What date did you first receive or spend money on this election?











The earliest date will be the start date of your disclosure period.



Your end date is 30 days after the day of the election you just took part in.

Part D – the money you spent or received



You need to tell us how much money you spent on the election.



This includes any money you spent to tell people:

- you are a candidate
- why they should vote for you.

We call this advertising.



For example, advertising on:

- TV or radio
- the internet like social media.



Advertising can also include:

- posters
- flyers on community noticeboards.











It also includes any money you spent on research.

For example, asking people what they think.

We sometimes call this an opinion poll.



We need to know about any money you:

- received like gifts
- borrowed like loans.



We also need to know how many people gave you money.



If you didn't spend or receive any money, you should write '0' on the form.



If you spent or received more than \$500, please call us.

When you became a candidate, you set up a bank account.

You need to include a copy of your bank statement when you send us this form.





The bank statement should show all the money you spent and received during the disclosure period.



If you do not have your bank statement, you should still send your Election summary return to us.
