## Primary Election Declaration – Early Voting Centres QUEENSLAND STATE GENERAL ELECTION SATURDAY 26 OCTOBER 2024



Under section 185E(2), this notice declares that during early voting, candidates, and registered political parties endorsing a candidate who are contesting an electorate listed in **Column B**, may display election signs consistent with sections 185A to 185H of the *Electoral Act 1992*, at the corresponding early voting centres set out in **Column A**.

The election for the electoral district in which a voting office or polling booth is located is automatically a primary election under section 185E(1)(a).
