All nominations must **reach the Electoral Commission of Queensland (ECQ) no later than midday on Friday, 25 October 2024.** A nomination form is printed with this notice. Additional forms can be obtained from the Union, the office of the ECQ and the ECQ's website; **www.ecq.qld.gov.au**.

To be eligible to nominate, candidates must be a duly elected member of council (General Member and Branch Representatives).

Nominations may be received by hand delivery, post, fax or email. Nominations must be signed by the candidate and one (1) duly elected member of Council. Nominees should ensure that their nomination is received by the ECQ and can be clearly read.

Candidate Statements

Candidates may lodge a statement (on a single A4 sheet of plain paper) supporting their election to the position sought. These statements are included with eligible voters' ballot material. Statements **must be received by the ECQ no later than the close of nominations.**

Ballot

If necessary, the ECQ will conduct a secret postal ballot of eligible members commencing on Wednesday, 13 November 2024 and closing at midday on Thursday, 28 November 2024. To be eligible to vote, members must be duly elected member of Council.

Ballots are decided by a first-past-the-post system of voting with candidates' names shown on the ballot paper in alphabetical order.
